**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On September 18, 2018, Anderson Water Company, Inc. (Anderson) filed an application for a rate change pursuant to Tex. Water Code (TWC) § 13.1871.

On January 26, 2022, the Office of Policy and Docket Management (OPDM) filed a memo establishing a deadline of February 14, 2022 for Staff (Staff) of the Public Utility Commission of Texas (Commission) and Anderson to file a clarification on specific issues. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Anderson and Staff (collectively, the Parties) are continuing to work on preparing a responsive filing to the OPDM memo; however, in order to prepare a fully responsive filing the Parties require additional time. Specifically, the Parties are working to prepare responsive information on the tap fees requested by the OPDM memo. Staff respectfully requests the entry of an order extending the deadline for Staff to file a response to OPDM’s memo to February 28, 2022.
