ORDER NO. 1 REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS AND NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Petition

This Order addresses the petition filed on September 19, 2018, by Denton Sorrells, LLC (Denton Sorrells) and Punkadilly, LTD (Punkadilly) requesting the expedited release of approximately 386 acres of land located within the boundaries of Aqua Texas, Inc.'s water certificate of convenience and necessity (CCN) No. 13201 in Denton County. The total acreage of land subject to the request includes approximately 324 acres owned by Denton Sorrells and approximately 62 acres owned by Punkadilly.

II. Requiring Comments on the Administrative Completeness of the Petition and Notice

By October 19, 2018, Commission Staff must file comments regarding the administrative completeness of the petition and notice.

Notice of this petition will be published in the *Texas Register*. A copy of the notice filed with the *Texas Register* will be provided to Aqua Texas, Inc. at their address of record as stated below:

In accordance with 16 Texas Administrative Code § 22.104(b) (TAC), Aqua Texas, Inc. must file a motion to intervene by October 19, 2018, in order to participate as a party in this proceeding.



III. Establishing Procedural Schedule

The following procedural schedule applies to this proceeding:

Publication of Texas Register notice	October 5, 2018
Commission Staff's comments on administrative completeness and notice	October 19, 2018
Deadline for Aqua Texas, Inc. and other affected persons to file a written protest or motion to intervene and file comments on the petition	October 19, 2018

Additional deadlines will be established after the petition is deemed administratively complete.

IV. Filing Requirements

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission's filing clerk in accordance with 16 Texas Administrative Code (TAC) § 22.71. A copy of each document filed with the Commission must also be served on all parties as required by 16 TAC § 22.74. All filings can be accessed on the PUC Interchange webpage at, http://interchange.puc.texas.gov.

All parties will provide their current addresses, telephone and fax numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, telephone, and fax information, if such information changes. The telephone and fax numbers will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

V. Ex Parte Communications

Ex parte communications with the administrative law judge (ALJ) or presiding officer are prohibited per 16 TAC § 22.3(b)(2). Parties should communicate with the ALJ or presiding officer only through written documents filed with the Commission's filing clerk and served on all parties.
