# PETITION OF BLOOMFIELD \$ PUBLIC UTILITY COMMISSION HOMES, L.P. TO AMEND JOHNSON \$ COUNTY SPECIAL UTILITY \$ OF TEXAS DISTRICT'S CERTIFICATE OF \$ CONVENIENCE AND NECESSITY IN \$ TARRANT COUNTY BY EXPEDITED \$ RELEASE

### COMMISSION STAFF'S FINAL RECOMMENDATION

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Final Recommendation in response to Order No. 2. In support thereof, Staff would show the following:

### I. BACKGROUND

On September 21, 2018, Bloomfield Homes, L.P. (Bloomfield) filed a petition with the Commission for expedited release from Johnson County Special Utility District's (Johnson County SUD) water Certificate of Convenience and Necessity (CCN) No. 10081 in Tarrant County, pursuant to Texas Water Code (TWC) § 13.254(a-5) and 16 Texas Administrative Code (TAC) § 24.245(*l*), formerly 16 TAC § 24.113(*l*). Bloomfield asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Tarrant County, which is a qualifying county.

On October 26, 2018, the Administrative Law Judge (ALJ) issued Order No. 2, requiring Staff to file a recommendation on final disposition by November 8, 2018. Therefore, this pleading is timely filed.

### II. STATUTORY APPROVAL DEADLINE

Pursuant to TWC § 13.254(a-5) and 16 TAC § 24.113(*l*), the Commission must render a decision on a petition for expedited release "not later than the 60th day after the date the landowner files the petition." A petition is not considered filed until it is deemed administratively complete. Bloomfield's petition was deemed administratively complete in Order No. 2, issued on October 26, 2018; therefore, the 60 day deadline for administrative approval is December 27,

2018. Since the Commission is closed on that day, administrative approval must be rendered on or before December 21, 2018.

### III. FINAL RECOMMENDATION

Staff has reviewed Bloomfield's petition and, as supported by the attached memorandum of Jolie Mathis of the Water Utilities Division (Attachment A), Staff recommends that the petition be approved. The maps and digital data submitted by Bloomfield provide adequate information to demonstrate that Bloomfield satisfies the requirements of TWC § 13.254(a-5) and 16 TAC § 24.113(*l*). Specifically, the petition shows that the property for which Bloomfield seeks expedited release is located in a qualifying county (Tarrant County), is not receiving water service, and that the aggregated, contiguous tracts of land make up a single property that is at least 25 acres. Bloomfield has shown through its petition that it meets the requirements for expedited release. Additionally, no property will be rendered useless or valueless as a result of this petition. Therefore, Staff recommends that the petition be approved.

The final map (Attachment B) and CCN Certificate (Attachment C) are attached to this filing.

### **IV. CONCLUSION**

For the reasons stated above, Staff respectfully recommends that Bloomfield's petition be approved.

On September 21, 2018, Bloomfield Homes, L.P. (or Petitioner) filed an application for expedited release from Johnson County Special Utility District's (Johnson County SUD) water Certificate of Convenience and Necessity (CCN) No. 10081 in Tarrant County, under Texas Water Code (TWC) Chapter § 13.254(a-5) and 16 Texas Administrative Code (TAC) § 24.245(*I*), formerly § 24.113(*I*). The Petitioner asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Tarrant County, which is a qualifying county.

The Petitioner submitted adequate maps delineating the requested area for expedited release with enough detail to confirm the accurate positioning of their digital data pursuant to 16 TAC § 24.257, formerly § 24.119. The map and digital data are sufficient for determining the locations of the requested release areas within Johnson County SUD's certificated area. Mapping Staff was able to confirm the acreage of the subject properties, and determined that the requested areas are located within the subject property. Furthermore, the Petitioner provided warranty deeds confirming the Petitioners' ownership of the tracts of land within the subject property. In addition, the Petitioner submitted a sworn affidavit attesting that the property was not receiving water from the CCN holder. The area being requested for expedited release is approximately 100.2 acres. The petition also included a statement indicating a copy of the petition was sent via certified mail to Johnson County SUD, the current holder of CCN No. 10081, on the date the petition was filed with the Commission.


In addition, Staff recommends that there is no useless or valueless property, in accordance with § 24.245(n)(3), formerly § 24.113(n)(3). Staff further recommends that a compensation proceeding is not necessary, if the Commission determines that there is no useless or valueless property, pursuant to 24.245(n)(7), formerly § 24.113(n)(7).

Staff is convinced the requested area does meet the requirements of TWC  $\S$  13.254(a-5) and 16 TAC  $\S$  24.245(l), formerly  $\S$  24.113(l). Therefore, Staff recommends approval of the petition. Enclosed is a final map and certificate for Commission approval.
