- 1. My name is Amber G. Chidester. I am employed by Southwestern Public Service Company ("SPS") as Regulatory Administrator. I am authorized to make this affidavit and I have personal knowledge of the facts stated herein.
- 2. On September 27, 2018, SPS filed with the Public Utility Commission of Texas an application for authority to implement a net refund for over-collected fuel costs. The application has been assigned PUC Docket No. 48718.
- 3. On September 27, 2018, SPS served notice of the application by regular first-class mail, hand delivery, or Federal Express to all parties who participated in SPS's most recent fuel reconciliation proceeding, Docket No. 46025. A list of those to whom notice was sent is attached as Exhibit A.
- 4.
