**ORDER NO. 2  
REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS AND NOTICE;  
AND ESTABLISHING PROCEDURAL SCHEDULE**

**I. Petition**

This Order addresses the petition filed by Charmaine Mirander Wilke on October 2, 2018, and subsequently amended on October 15, 2018, requesting the expedited release of approximately 150 acres of land located within the boundaries of Tri-Community Water Supply Corporation's water certificate of convenience and necessity number 10313 in Guadalupe County.

**II. Requiring Comments on the Administrative Completeness**

By November 1, 2018, Commission Staff must file comments regarding the administrative completeness of the petition and notice.

The Commission will publish an amended notice of the petition in the *Texas Register*. The Commission will provide a copy of the notice filed with the *Texas Register* to Tri-Community Water Supply Corporation at its address of record:

In accordance with 16 Texas Administrative Code (TAC) § 22.104(b), Tri-Community Water Supply Corporation must file a motion to intervene by November 1, 2018, in order to participate as a party in this proceeding.

### IV. Filing Requirements

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission's filing clerk in accordance with 16 TAC § 22.71. A copy of each document filed with the Commission must also be served on all parties as required by 16 TAC § 22.74. All filings can be accessed on the PUC Interchange webpage at, <http://interchange.puc.texas.gov>.

All parties will provide their current addresses, telephone and fax numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, telephone, and fax information, if such information changes. The telephone and fax numbers will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

### V. Ex Parte Communications

*Ex parte* communications with the administrative law judge (ALJ) are prohibited under 16 TAC § 22.3(b)(2). Parties should communicate with the ALJ only through written documents filed with the Commission's filing clerk and served on all parties.
