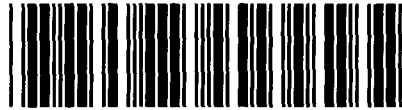

COMMISSION STAFF'S CORRECTIONS TO THE NOTICE OF APPROVAL

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files these Corrections to the Notice of Approval. In support thereof, Staff shows the following:

I. BACKGROUND

On October 9, 2018, Tonkawa Farms, L.P. (Tonkawa), filed a petition with the Public Utility Commission of Texas (Commission) for expedited release from Pattison Water Supply Corporation's (Pattison WSC) water Certificate of Convenience and Necessity (CCN) No. 10331 pursuant to Texas Water Code (TWC) § 13.254(a-5) and 16 Texas Administrative Code (TAC) § 24.245(l) (formerly 16 TAC § 24.113(l)).

Tonkawa owns 618.151 acres of contiguous property in Waller County, Texas (Property). Furthermore, 288.65 acres of the Property is located within the boundaries of water CCN No. 10331. Additionally, the Property is not receiving service from any water service provider.

There were no intervenors in the docket and no hearing was requested. The application qualified for informal disposition.

On January 22, 2019, the Commission administrative law judge (ALJ) issued a notice of approval in this docket. Under the Commission rules, specifically, 16 Texas Administrative Code (TAC) § 22.35, parties may file suggested corrections to a notice of approval within fifteen (15) days of the issuance of such notice. Therefore, Staff's suggested corrections in this pleading are timely filed.¹

¹ Fifteen (15) days from the date the notice of approval was issued (January 22, 2019) is Wednesday, February 6, 2019.

II. STAFF'S PROPOSED CORRECTIONS

Staff proposes the following corrections to the notice of approval:

Modify Finding of Fact No. 2 to clarify that Tonkawa Farms' petition did not request expedited release for the entire 618-acre tract of land in Waller County.

2. On October 9, 2018, Tonkawa Farms filed a petition for the expedited release of a portion of the 618-acre tract in Waller County.

Modify Finding of Fact No. 8 to insert a word for clarity.

8. Tonkawa Farms attested that a copy of the petition had been sent by certified mail to the current CCN holder on the same day of the filing of the petition.

Modify Ordering Paragraph No. 2 to correctly identify Pattison WSC's CCN number.

2. The Commission amends Pattison WSC's CCN number ~~10313~~ 10331 in accordance with this Notice.

III. CONCLUSION

Staff respectfully requests that the Commission ALJ adopt the corrections proposed above.
