UNOPOSED MOTION TO ADMIT EVIDENCE AND REMAND PROCEEDING

On July 26, 2022, Entergy Texas, Inc. ("ETI"), the Staff of the Public Utility Commission of Texas ("Staff"), the Office of Public Utility Counsel ("OPUC") and the Mission Data Coalition, Inc. ("Mission:data") filed a Stipulation and Settlement Agreement ("Stipulation") resolving all substantive issues in this proceeding. In accordance with the Agreement, ETI submits this Unopposed Motion to Admit Evidence and Remand to the Commission.

I. MOTION TO ADMIT EVIDENCE

ETI respectfully request that the following documents be admitted into evidence in this matter:

- 1. ETI's compliance filing filed on October 9, 2018;
- 2. ETI's proof of notice filed on October 30, 2018;
- 3. The Stipulation and its attachments and exhibits filed on July 26, 2022; and
- 4. Settlement Testimony of Richard E. Lain for ETI in support of the Stipulation.

II. MOTION TO REMAND PROCEEDING

ETI filed, on behalf of the parties, an agreed proposed order that addresses and resolves all issues in this proceeding. ETI requests the ALJ enter an order dismissing this proceeding from the State Office of Administrative Hearings docket and remanding it to the Commission for consideration of the settlement agreement and proposed order. ETI is authorized to represent that Staff, OPUC, and Mission:data support this motion and entry of the proposed order.

III. CONCLUSION

ETI respectfully requests that the ALJ grant this motion to admit evidence and remand the proceeding to the Commission and enter an order consistent with the foregoing motions.
