COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Commission Staff's Request for an Extension and would show the following:

I. BACKGROUND

On October 11, 2018, Aqua Utilities, Inc. (Aqua Utilities) and Aqua Development, Inc. (Aqua Development) filed an application for approval of a sale, transfer, or merger to Aqua Texas, Inc. (Aqua Texas) of facilities and certificate rights in Bandera, Bastrop, Bexar, Blanco, Burnet, Comal, Gillespie, Hays, Kendall, Kerr, Kimble, Live Oak, Llano, Medina, Nueces, Travis, Williamson, and Wilson Counties.

On June 14, 2019, the Commission issued an Order requiring the parties to submit a joint proposed order approving the sale and allowing the transaction to proceed by or on July 15, 2019. Therefore, this pleading is timely filed.

II. REQUEST FOR AN EXTENSION

Staff is currently waiting on information from the applicant that is required for the joint proposed order, and Staff does not have access to that information. Thus, Staff requests that the deadline to file a joint proposed order be extended seven (7) days from the July 15, 2019 deadline to July 22, 2019, in order to give the applicant additional to access the information and include it in the joint proposed order.

III. CONCLUSION


Staff respectfully requests the above extension.


