STATUS REPORT NO. 2

COME NOW Aqua Utilities, Inc., Aqua Development, Inc., and Aqua Texas, Inc. (collectively, "Applicants") and file this Status Report No. 2 regarding the status of the Applicants' efforts to conclude the transaction, address customer deposits, and submit evidence of same.

On October 11, 2018, Applicants filed an Application for Sale, Transfer, or Merger of Facilities and Certificate Rights in Bandera, Bastrop, Bexar, Blanco, Burnet, Comal, Gillespie, Hays, Kendall, Kerr, Kimble, Live Oak, Llano, Medina, Nueces, Travis, Williamson, and Wilson Counties, Texas. The application seeks to consolidate certain systems and service areas under Aqua Texas, Inc. and regional CCNs issued to same. Aqua Utilities, Inc. seeks approval to transfer to Aqua Texas, Inc. a significant number, but not all, of its remaining water and sewer facilities/service areas under certificate of convenience and necessity (CCN) numbers 11157 and 20453. Aqua Development, Inc. seeks approval to transfer to Aqua Texas, Inc. all of its remaining water and sewer facilities/service areas that are used or useful in the provision of water and sewer service under CCN numbers 12902 and 20867. Further, Aqua Texas, Inc. seeks approval to receive



all of the assets and service areas described in the application from Aqua Utilities, Inc. and Aqua Development, Inc. for inclusion in Aqua Texas, Inc. water CCN No. 13254 and a new sewer CCN.

On August 22, 2019, the Commission approved the Applicants' proposed transaction to proceed.

The Applicants are working diligently on the steps needed to close the approved transaction and will address customer deposits as part of that process. However, the transaction is not closed at this time.
