SUPPLEMENTAL APPLICATION INFORMATION RELATED TO PARENT CORPORATION NAME CHANGE

COME NOW Aqua Utilities, Inc., Aqua Development, Inc., and Aqua Texas, Inc. (collectively, "Applicants") and file this Supplemental Application Information Related to Parent Corporation Name Change. In support, Applicants would show as follows.

Applicants' parent corporation recently changed its name from Aqua America, Inc. to Essential Utilities, Inc. The change is evidenced by Articles of Amendment filed on January 30, 2020 with the Pennsylvania Department of State and was effective February 3, 2020.

This name change did not entail a change of controlling interest in the Applicants as the parent corporation remains the same legal entity as before. Thus, this name change did not invoke requirements applicable to controlling interest changes prescribed by the Texas Water Code and Commission rules.² Yet, Applicants are filing this information for two reasons: (1) to make the Commission aware of the change; and (2) to ensure the Commission's final order in this proceeding references the proper name of the Applicants' parent corporation where appropriate.
