**COMMISSION STAFF'S REQUEST FOR AN EXTENSION**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Commission Staff's Request for an Extension and would show the following:

**I. BACKGROUND**

On October 11, 2018, Aqua Utilities, Inc. (Aqua Utilities) and Aqua Development, Inc. (Aqua Development) filed an application for approval of a sale, transfer, or merger to Aqua Texas, Inc. (Aqua Texas) of facilities and certificate rights in Bandera, Bastrop, Bexar, Blanco, Burnet, Comal, Gillespie, Hays, Kendall, Kerr, Kimble, Live Oak, Llano, Medina, Nueces, Travis, Williamson, and Wilson Counties.

On October 16, 2018, the Commission issued an Order requiring Commission Staff to file comments on the administrative completeness of the application and proposed notice by November 10, 2018. Therefore, this pleading is timely filed.

**II. REQUEST FOR AN EXTENSION**

Due to the complexities of the mapping filed with the application, Staff needs additional time to review the mapping. Accordingly, Staff hereby requests that the deadline to file comments on the administrative completeness of the application and proposed notice be extended thirty (30) days from the November 10, 2018 deadline to December 10, 2018.
