ORDER NO. 3 FINDING APPLICATION ADMINISTRATIVELY INCOMPLETE AND ESTABLISHING AN OPPORTUNITY TO CURE

This Order addresses the application of Aqua Utilities, Inc. (Aqua Utilities), Aqua Development, Inc. (Aqua Development), and Aqua Texas, Inc. (Aqua Texas) for approval of a sale, transfer, or merger from Aqua Utilities and Aqua Development to Aqua Texas of facilities and certificate rights in Bandera, Bastrop, Bexar, Blanco, Burnet, Comal, Gillespie, Hays, Kendall, Kerr, Kimble, Live Oak, Llano, Medina, Nueces, Travis, Williamson, and Wilson Counties.

On December 10, 2018, Commission Staff filed a recommendation that the application be deemed administratively incomplete. For the reasons identified in Commission Staff's recommendation, the ALJ finds the application incomplete and deficient. The Commission does not consider applications of this type filed until the Commission has made a determination of administrative completeness; therefore, at this time the application is not considered filed with the Commission.

On or before January 10, 2019, applicants must supplement the application to cure the deficiencies identified by Commission Staff. Until the deficiencies have been rectified, processing of the application cannot proceed. The applicants must not issue notice until the application is administratively complete.

On or before February 8, 2019, Commission Staff is required to file a supplemental recommendation regarding administrative completeness, along with a proposed procedural schedule, if appropriate.
