Certificate of Convenience and Necessity No. 10194

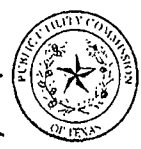

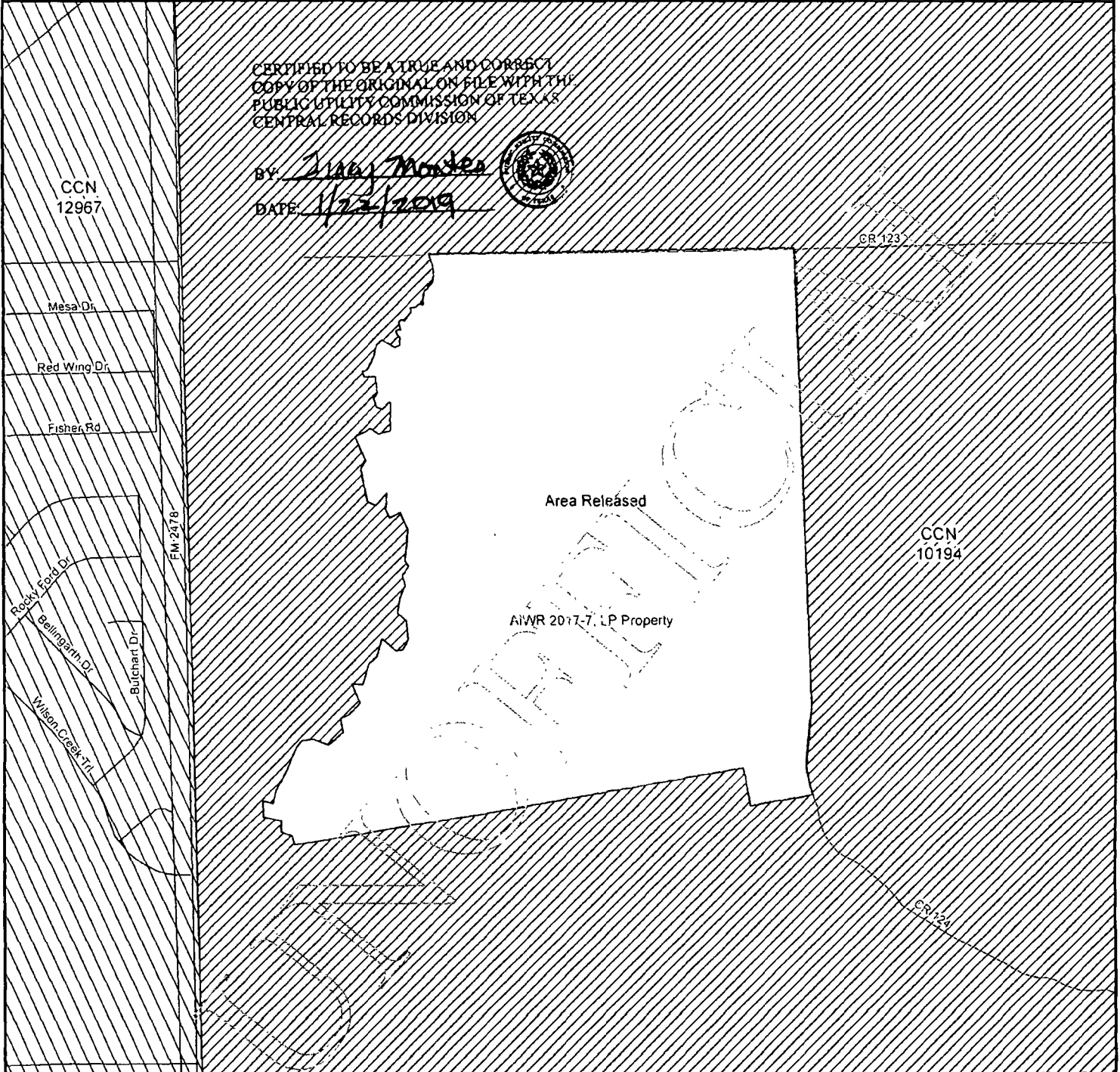

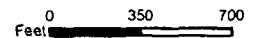
