

G-M Water Supply Corporation, 405 Hwy 87N, Hemphill, Texas 75948 has submitted an application with the Public Utility Commission of Texas (Commission) to purchase water facilities and cancel Pendleton Harbor Water Supply Corporation's CCN No. 10737 in Sabine County, Texas.

Pendleton Harbor Water Supply Corporation, 200 Sand Dollar Drive, Hemphill, Texas 75948 is the Seller.

The sale is scheduled to take place as approved by the Commission (V.T.C.A., Water Code §13.301). The transaction and the transfer of the CCN includes the following subdivision: **PENDLETON** HARBOR SUBDIVISION.

The requested area subject to this transaction is located approximately 9.3 miles northeast of downtown Hemphill, Texas, and is generally bounded on the north by Toledo Bend Reservoir; on the east by Toledo Bend Reservoir; on the south by State Highway 21 and Toledo Bend Reservoir; and on the west by intersection of Cedar Grove Road and Elma Lane. The total requested area for the water CCN being transferred and amended includes approximately 1,024 acres and 234 current customers. See enclosed map showing the requested area.

This transaction will have the following effect on the customers' rates and services: All of the customers will be charged G-M's current rates.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P. O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing and speech impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is 30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer. You must send a letter requesting intervention to the commission which is received by that date.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large scale map and a metes and bounds description of the landowner's tract of land. Persons who wish to request this option should file the required documents with the:
