COMMISSION STAFF'S AMENDED RECOMMENDATION ON FINAL DISPOSITION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Commission Staff's Amended Recommendation on Final Disposition and would show the following:

I. BACKGROUND

On October 18, 2018, T.J. Bradshaw Construction, Ltd. (Petitioner) filed a petition with the Commission for expedited release from Jonah Special Utility District's (Jonah SUD) water Certificates of Convenience and Necessity (CCN) No. 10970 and sewer CCN No. 21053 pursuant to Texas Water Code (TWC) § 13.254(a-5) and 16 Texas Administrative Code (TAC) § 24.245(l). On October 23, 2018, Petitioner amended its application.

Petitioner asserts that it owns 256.33 acres of contiguous property in Williamson County (the Property), located within the boundaries of Jonah SUD's water and sewer CCNs. Petitioner also asserts that the Property is not receiving water or sewer service.

On December 18, 2018 Staff filed a Recommendation on Final Disposition.

II. AMENDED RECOMMENDATION ON FINAL DISPOSITION

Staff inadvertently forgot to attach a final map to its December 18, 2018 Recommendation on Final Disposition. This pleading remedies that error.

III. CONCLUSION

Staff respectfully requests that the ALJ issue an order consistent with the above recommendation.


