ORDER NO. 4
FINDING NOTICE SUFFICIENT, ESTABLISHING A PROCEDURAL SCHEDULE,
AND ADDRESSING PENDING MOTIONS

In this matter, Campbell Water Supply Corporation seeks to amend its water certificate of convenience and necessity (CCN) in Hunt County.

I. Finding Notice Sufficient and Establishing a Procedural Schedule

On March 20, 2019, Campbell WSC filed the affidavit of Eddy Daniel, P.E., Engineer/Consultant, attesting that notice was provided on February 6, 2019 to landowners, neighboring utilities and cities and affected parties in the requested service area. Campbell WSC also filed the affidavit of Kerri Gibbs, ad director, attesting that notice was published in the *Commerce Journal* on January 31, 2019, and February 7, 2019.

The administrative law judge finds notice sufficient and establishes the following procedural schedule:

II. Granting Motion to Intervene

On March 6, 2019, Malloy Water Supply Corporation filed a motion to intervene. Malloy WSC has a justiciable interest in this proceeding. No party objected to the motion. The administrative law judge grants Malloy WSC's motion to intervene.

III. Deferring Ruling on Request for Referral to SOAH

On March 6, 2019, Malloy WSC filed a request for a contested hearing, asking that the docket be transferred to the State Office of Administrative Hearings (SOAH). On March 18, 2019, Campbell WSC filed a letter indicating it was in the process of working with Malloy WSC to resolve the issue without the need for a hearing. The request for a contested case hearing will be addressed in a subsequent order to allow the parties to continue working toward resolution.
