COMES NOW the intervening party "Mark Parker" file this Status Report in Response to SOAH Order No. 2. In support thereof, shows the following:

I. BACKGROUND

I (Mark Parker) received various Rate Increase Documents/notifications/intervention deadlines from Northtown Acres Water Supply (Northtown Acres) as following:

1. A proposed rate increase dated 1/30/19 for a 42.9% rate increase and I protested.
2. A proposed rate increase dated 6/26/19 for a 61.15% rate increase and I protested.
3. An approved 19% Interim Tariff Rate Increase Dated 11/18/19 received 12/5/19 with the November Water Bill with included the additional 19% rate increase.
4. A Notice of Intervention Deadline Document (a non dated document) but received during the Christmas/New Years Holidays (along with the December Water Bill - approximately received 12/28/19). It said Must File Written Request to Intervene by 3:pm on January 15, 2020. The notice contained a Docket NO. 48819 (for PUC) but did not contain a State Office of Administration Hearing (SOAH) Docket No. I (Mark Parker) Completed a Motion to Intervene Dated Sunday 12/29/19 and mailed to 12/30/19.

STATUS REPORT

I (Mark Parker) believe the late notice for intervention and the fact it was mailed and delivered during the Christmas/New Years Holidays and also being incomplete without the SOAH Docket Number - all warrants that Notice Deficient. The Homeowners were not given enough time to respond.


