SOAH ORDER NO. 8 LIFTING ABATEMENT; SETTING PREHEARING CONFERENCE

This matter was abated on February 10, 2020, to allow Northtown Acres Water Supply (Northtown Acres) to complete a sale, transfer, merger (STM) application. On November 2, 2020, Northtown Acres filed a status report stating that the Public Utility Commission had approved the STM application and requesting to lift the abatement. The abatement is **LIFTED**.

In response to the COVID-19 pandemic, the State Office of Administrative Hearings (SOAH) is currently conducting all non-emergency hearings by remote technologies to the extent feasible. Accordingly, a prehearing conference will be convened using the Zoom videoconferencing platform. The prehearing conference will convene at 10:00 a.m. on December 10, 2020, via Zoom videoconference. The purpose of the prehearing conference is to address a procedural schedule, including whether any amendments to the application or supplemental notice to customers is necessary, as well as whether mediation is appropriate. If the parties are able to reach an agreement on these issues, they may request cancellation of the prehearing conference by making a joint filing setting forth their agreement by December 8, 2020.
