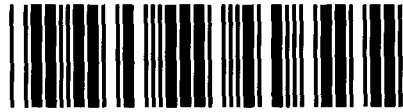

**DEFINITIONS**

- A. "Applicants," or "you" refers to Crazy Horse Ranchos Water System and Patterson Water Supply, LLC and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B. - Staff 1-1** Provide a detailed listing of the cost necessary for any upgrades to Crazy Horse Ranch System.
- Staff 1-2** Provide the original value and accumulated depreciation amount for each of the assets listed on Crazy Horse Ranchos Water System– PWS ID 1840024 Inventory page provided with the application.
- Staff 1-3** Please refer to Schedule 15 C of the application. Provide a complete balance sheet including all assets, liabilities and owner equity in regards to the Current Assets & Current Liabilities Statement as of September 31, 2018.
- Staff 1-4** Complete question 14 of the application based on the financial information provided in response to request #2, and #3, above, and Patterson Water Supply LLC 2018 Financial Statements.
- Staff 1-5** Complete question 11 B. of the application.
- Staff 1-6** Provide a copy of TCEQ's acknowledgement letter for plans and specs submittal for Line Extension for Interconnection to connect wells.
- Staff 1-7** Describe in detail the current nature of the ownership of the Crazy Horse Ranchos Water System assets and infrastructure.
- Staff 1-8** Provide documents that show that the applicant has the legal authority to transfer the assets.
