(MSEC) is pleased to notify you that it has filed an application with the Public Utility Commission of Texas (PUC), in PUC Docket No. 48872, to approve the implementation of a Federal Tax Change Credit Rider (Credit Riders) effective for sewer bills rendered on or after May 1, 2019, or as soon thereafter as the filing if approved by the PUC. MSEC has developed the Credit Rider as a means to immediately pass along to its customers the estimated savings resulting from the corporate income tax rate reduction accomplished by the Federal Tax Cuts and Jobs Act of 2017. The Credit Rider will immediately lower your monthly bills and will be noted on your bill until MSEC's next sewer rate proceeding.

The Credit Rider for sewer customers varies by the size of your meter. Starting on May 1, 2019, or as soon as the PUC approves MSEC's application, whichever is later, and continuing until MSEC changes its sewer rates, the credit for a 1" meter will be \$1.50, for a 2" meter the credit will be \$4.11, for a 3" meter the credit will be \$97.42, for an 8" meter the credit will be \$120.36, and for a 10" meter the credit will be \$190.57 per month. In addition, there will be an additional credit applied to each bill for an eight-month period after the implementation of the credit, to credit you with the lower tax rate beginning on September 1, 2018. The amount of this additional credit will vary, depending on when the PUC issues its final notice of approval.

In addition, there will be an additional credit applied to each bill for an eight-month period after the implementation of the credit, to credit you with the lower tax rate beginning on September 1, 2018. The amount of this additional credit will vary, depending on when the PUC issues its final notice of approval.
