JOINT CORRECTIONS TO PROPOSED ORDER

COMES NOW MSEC Enterprises, Inc. (MSEC), together with the Staff of the Public Utility Commission of Texas (Staff), representing the public interest (collectively, Parties), and file these Joint Corrections to the Proposed Order.

The Parties have identified two corrections that should be made to the Proposed Order, as follows:

<u>Finding of Fact No. 2</u>: In addition to Montgomery County, MSEC also provides water service in Grimes County. Therefore, this Finding of Fact should be corrected to include Grimes County:

2. MSEC provides water and sewer service under certificates of convenience and necessity numbers 12887 and 20984 in Montgomery and Grimes Counties.

<u>Finding of Fact No. 12</u>: The reduction in revenue for water in the amount of \$104,837.52 is in error. Staff's Final Recommendation inadvertently transposed two numbers; Staff has filed a correction to its Final Recommendation to correct the revenue requirement number that should be contained in this Finding of Fact, to-wit: \$140,837.52:¹

12. The proposed FTCC riders reflect the reduction in revenue requirement of \$140,837.52 for water and \$5,115.69 for sewer based on its 2017 actual historical information.

The Parties respectfully request that the Proposed Order be revised to include the corrections noted herein.
