DEFINITIONS

- Staff 1-1 Reference the Company's Annual Report¹ in Docket No. 47833, page 4, line 18, Federal Income Taxes of (\$344,694). Provide a detailed explanation as to why these taxes are negative.
- Staff 1-2 Reference the Company's filing, claim of Earnings Before Taxes of \$794,726 for water and \$28,867.11 for sewer. Show a detailed calculation of these numbers using the 2017 Annual Report filed by the Company in Docket No. 47833.
- Staff 1-3 Provide a detailed calculation of the Margins tax (Texas Franchise Tax) for:
 - a. 2017; and
 - b. 2018.
- Staff 1-4 Provide a copy of the most current Texas Franchise Tax Report completed that includes MSEC's income and financial information used to calculate the tax.
