RE: Petition by the City of Celina and Marilee Special Utility District for Approval and Enforcement of Service Area Contract under Texas Water Code § 13.248 and to Amend Certificates of Convenience and Necessity in Collin County

Marilee Special Utility District ("MSUD") and the City of Celina (the "City"), (collectively, the "Applicants"), through the City's engineer, TRC Engineers, Inc., files this Petition for Approval and Enforcement of Service Area Contract under Texas Water Code § 13.248 ("Application") to amend Certificate of Convenience and Necessity ("CCN") of the Applicants. The relief requested affects a portion of the City's water CCN No. 12667 and a portion of MSUD's water CCN No. 10150, both located in Collin County, Texas.

The Applicants file this Petition to seek Commission action to approve and enforce a contract expressing the Applicant's agreement to transfer portions of each's CCN. The specific transfer area and terms are more specifically set forth in the executed Fourth Addendum to the Full and Final Settlement Agreement and Release, attached to this Petition. There are currently no customers being served within this area. There will not be any transfer of assets or facilities between the Applicants.

The Applicants hereby provide the following information in furtherance of Commission approval for the CCN service area designations contemplated by this Petition:

- 1. Maps of the 2,254.74 acres transfer area, included as Attachments 1 and 2.
- 2. A copy of the executed agreement pertaining to this amendment, titled "Fourth Addendum to the Full and Final Settlement Agreement and Release", included as Attachment 3.
- 3. The number of customers to be transferred is 0.
- 4. Assets or facilities to be transferred is none.





FOURTH ADDENDUM TO THE FULL AND FINAL SETTLEMENT AGREEMENT AND RELEASE

This Fourth Addendum is being entered into to modify the Full and Final Settlement Agreement and Release executed by the parties on April 24, 2001 (the "Agreement") in the above referenced case based on the following considerations:

WHEREAS, based on a modification of the policy of the City of Celina (the "City") relating to annexations, the City has requested that Marilee Special Utility District f/k/a Gunter Special Utility District f/k/a Gunter Rural Water Supply Corporation (the "District") modify Section C.9 of the Agreement and add the Exhibit 1, attached hereto and incorporated herein for all purposes, as Exhibit "I" to the Agreement; and

WHEREAS, the District has determined that it is the best interests of all concerned that Section C.9 of the Agreement be modified and add the attached <u>Exhibit 1</u> to be added as Exhibit "I" to the Agreement in order to accommodate the City.

NOW THEREFORE, the City and the District agree as follows:

- 1. Section C.9 of the Agreement is modified to provide as follows:
 - "9. The term "District" shall mean Marilee Special Utility District f/k/a Gunter Special Utility District f/k/a Gunter Rural Water Supply Corporation, and being the same entity as "Gunter" or "Defendant" as defined herein this Agreement.
 - (a) Except for the three subdivisions set forth above in paragraph C.8 and below in paragraph C.9.(d), Celina shall pay the District within sixty (60) days from the last of the following actions to occur: (i) the voluntary annexation of any developed areas that are within the District's CCN and (ii) Celina's initiation of water service to the areas voluntary annexed, according to the following terms:

- ** The greater of the per meter price or the per acre price for developed areas. As used herein, compensation for meters shall be determined by the number of water meters physically located on the ground within the CCN area being annexed by Celina as of the date of an annexation ordinance.
- (b) Except for the three subdivisions set forth above in paragraph C.8 and below in paragraph C.9.(d), Celina shall pay the District within sixty (60) days following the involuntary annexation of any developed areas that are within the District's CCN according to the following terms:

- ** The greater of the per meter price or the per acre price for developed areas. As used herein, compensation for meters shall be determined by the number of water meters physically located on the ground within the CCN area being annexed by Celina as of the date of an annexation ordinance.
- (c) Except for the property set forth below in paragraph C.9.(d), Celina shall pay the District for any undeveloped area that is located wholly or partially within the District's CCN on or before the thirtieth (30th) day following Celina's approval of a final plat of any territory located wholly or partially within the District CCN.

The amount to be paid by Celina to the District for the District's CCN for undeveloped areas will be determined by the year in which the payment is due pursuant to the following:

- (d) Celina shall acquire from the District the portion of the District's CCN found in Exhibit "I", attached hereto and incorporated herein for all purposes, (the "2018 Territory"), upon Celina's annexation of the 2018 Territory.
 - (i) The District shall receive Five Hundred Dollars (\$500.00) per acre for the 2,254.74 acres within the 2018 Territory for a total

amount not to exceed **One Million One Hundred Twenty-Seven Thousand Three Hundred Seventy Dollars (\$1,127,370.00)** from Celina. Such payment for the 2018 Territory shall be made to the District in five (5) equal annual installments at the interest rate of zero percent (0%) per annum, with each payment equaling Two Hundred Twenty-Five Thousand Four Hundred Seventy-Four Dollars (\$225,474.00) due October 15th of each year, beginning October 15, 2019.

- (ii) If Celina executes a development agreement with the property owner(s) of the 2018 Territory, then Celina shall pay the District full payment and/or any remaining payments for the 2018 Territory within twelve (12) months from the executed date of such development agreement.
- (e) Within ten (10) days following approval, the City will deliver to the District a true and correct copy of each final plat that is approved by the City that relates to any territory that this located wholly or partially within the District's CCN.
- (f) Any payments required by this Agreement that are not paid on or before the due date will earn interest at the rate of one percent (1%) per month from and after the due date."
- 2. The attached <u>Exhibit 1</u> to this Fourth Addendum, which depicts the 2018 Territory, shall be added to the Agreement as Exhibit "I" of the Agreement.
- 3. The City and the District ratify, affirm and republish the Agreement, as modified herein, as a valid and enforceable agreement between the parties pursuant to its terms.
- 4. The undersigned, on behalf of a party to this Addendum, by their signatures, bind, covenant, represent and warrant that they have the authority of their principal to bind it to the terms, covenants and conditions of this Addendum and the Agreement.

IN WITNESS WHEREOF, the parties hereto have executed this Fourth Addendum on the dates set forth in the respective acknowledgments.




