**MOTION TO VOLUNTARILY WITHDRAW APPLICATION  
AND DISMISS DOCKET NO. 48892**

TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW, Alpha Ranch Fresh Water Supply District and Brookfield Fresh Water Supply District (the "Applicants") and file this Motion to Voluntarily Withdraw the Application and, thereafter, to dismiss the pending Public Utility Commission of Texas Docket No. 48892 and, in support thereof, would show the following.

**I. BACKGROUND**

On November 19, 2018, Applicants filed the Application pursuant to Section 13.254, Texas Water Code. The Application remains pending and has not yet been declared to be "administratively complete" for purposes of continued processing. Applicants have consulted with PUC Staff and have concluded that additional information should be gathered and in consideration of judicial economy and the beneficial use of the resources of all of the Parties to this Docket, Applicants should seek dismissal of this Docket No. 48892.

**II. MOTION TO VOLUNTARILY WITHDRAW & DISMISS**

Pursuant to 16 Texas Administrative Code § 22.181(g)(1) (TAC), the party that initiated a proceeding may withdraw its application, without prejudice to refile, at any time before that party has presented its direct case. Based upon the withdrawal of the Application in this Docket

No. 48892, Applicants move for dismissal of Docket No. 48892, without prejudice, under 16 TAC § 22.181(g)(5).


### III. CONCLUSION & PRAYER
