### UNOPPOSED REQUEST FOR EXTENSION OF TIME TO FILE STATUS REPORTS

COME NOW Kerrville South Water Company, Inc. and Aqua Texas, Inc. ("Aqua") (collectively, "Applicants") and file this unopposed request for an extension of time to file status reports in this docket regarding efforts to conclude the transaction approved to proceed in Order No. 4. In support, Applicants respectfully show the following.

On March 22, 2019, the Commission approved the Applicants' proposed transaction to proceed.<sup>1</sup> Simultaneously, the Commission directed the Applicants to file monthly status reports regarding their efforts to conclude the transaction beginning April 15, 2019.<sup>2</sup> Separately, the Commission approved a similar transaction to proceed involving Aqua and Harper Water Company, Inc.<sup>3</sup> However, in that docket the applicants were ordered to file monthly status reports beginning April 22, 2019.

For administrative efficiency, Aqua would like to file monthly status reports in Docket Nos. 48896 and 48897 on the same day each month. Therefore, the Applicants respectfully request an extension of the initial status report to April 22, 2019. Further, Applicants request that additional reports be due monthly in this docket beginning April 22, 2019 instead of April 15, 2019. Applicants have conferred with Commission Staff about the status report deadline extension request contained herein. Commission Staff is unopposed.


