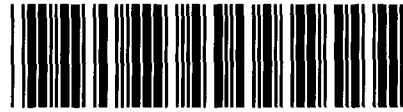

**GOLDEN SPREAD ELECTRIC COOPERATIVE INC.'S**  
**STATEMENT OF POSITION**

COMES NOW, Golden Spread Electric Cooperative, Inc. ("Golden Spread"), and files this Statement of Position in lieu of Testimony in the above-captioned proceeding. In support thereof, Golden Spread shows the following:

In this proceeding, Oncor Electric Delivery Company, LLC ("Oncor"), Sharyland Distribution and Transmission Services, L.L.C. ("SDTS"), Sharyland Utilities, L.P. ("Sharyland"), and Sempra Energy ("Sempra") (collectively, "Joint Applicants") seek Commission authority to exchange certain transmission assets, including certain assets that interconnect Golden Spread's Antelope Elk Energy Center into the Electric Reliability Council of Texas ("ERCOT")

Golden Spread has intervened in Dockets 48625, 48668 and 49151, which deal with Commission approval of the transmission facilities proposed by Sharyland and Lubbock Power and Light ("LP&L") to serve the City of Lubbock. Golden Spread's interests in Dockets 48625, 48668 and 49151 are still subject to Commission review and approval. The Commission's determinations in this proceeding may cause Oncor to become the successor in interest with respect to the Sharyland transmission facilities that are the subject of Dockets 48625, 48668 and 49151. The construction of these transmission facilities will have an impact on the operation of Golden Spread's Antelope Elk Energy Center. Moreover, Golden Spread buys and sells electricity that is carried by other transmission lines that may be transferred in this proceeding.
