# METHOD USED TO ALLOCATE UTILITY CHARGES

The size of the area rented by the tenant divided by the total area of all the size of rental spaces.

## Size of the rented space in a multi-use facility:

The square footage of the space rented by the tenant divided by the total square footage of all rental spaces.
