METHOD USED TO ALLOCATE UTILITY CHARGES

Occupancy method: The number of occupants in the tenant's dwelling unit is divided by the total number of occupants in all dwelling units at the beginning of the month for which bills are being rendered. Number of Occupants for Ratio occupancy method: **Number of Occupants Billing Purposes** 1.0 The number of occupants in the tenant's dwelling unit is adjusted as shown in the table to the right. Size of the rented space in a multi-use facility: The square footage of the space rented by the tenant divided by the total square footage of all rental spaces.
