I.

MOTION TO CONTINUE COMMISSION CONSIDERATION AND ACTION

Petitioner has been working to secure a solution that will avoid the necessity of decertification. Petitioner seeks a continuance of the scheduled February 28th Commission consideration on its agenda of the Petition until the April 4th Open Meeting to give Petitioner additional time to complete efforts to develop the alternative solution and avoid the need for decertification. If successful, Petitioner will be filing a motion to withdraw its petition prior to the April 4th Open Meeting. Accordingly, the request for continuance of the April 4th PUC Commissioner's Open Meeting is not for purposes of delay, but so that justice may be served.
