**ORDER NO. 1  
REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS AND NOTICE;  
AND ESTABLISHING PROCEDURAL SCHEDULE**

**I. Petition**

This Order addresses the petition filed on November 30, 2018, by AIRW 2017-7, L.P., requesting the expedited release of 138.413 acres of land located within the boundaries of the City of McKinney's water certificate of convenience and necessity number 20071 in Collin County.

**II. Requiring Comments on the Administrative Completeness**

By January 2, 2019, Commission Staff must file comments regarding the administrative completeness of the petition and notice.

The Commission will publish notice of the petition in the *Texas Register*. The Commission will provide a copy of the notice filed with the *Texas Register* to the City of McKinney at its address of record:

In accordance with 16 Texas Administrative Code (TAC) § 22.104(b), the City of McKinney must file a motion to intervene by January 2, 2019, in order to participate as a party in this proceeding.

### III. Establishing Procedural Schedule

The following procedural schedule applies to this proceeding:

Publication of <i>Texas Register</i> notice	December 14, 2018
Commission Staff's comments on the administrative completeness of the petition and notice	January 2, 2019
Deadline for the City of McKinney and other affected persons to file a written protest or motion to intervene and file comments on the petition	January 2, 2019

Additional deadlines will be established after the petition is deemed administratively complete.

### IV. Filing Requirements

Unless otherwise specified, an original and ten copies of documents relating to this proceeding must be filed with the Commission's filing clerk in accordance with 16 TAC § 22.71. A copy of each document filed with the Commission must also be served on all parties as required by 16 TAC § 22.74. All filings can be accessed on the PUC Interchange webpage at, <http://interchange.puc.texas.gov>.



Each party must provide the Commission and all parties with updated address, telephone, and fax information, if such information changes. The telephone and fax numbers will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

### V. Ex Parte Communications

*Ex parte* communications with the administrative law judge (ALJ) are prohibited under 16 TAC § 22.3(b)(2). Parties should communicate with the ALJ only through written documents filed with the Commission's filing clerk and served on all parties.
