COMMISSION STAFF AND PHONOSCOPE'S JOINT MOTION TO ABATE THE
FILING OF THE LIST OF ISSUES AND THE DOCKET

The Staff (Commission Staff) of the Public Utility Commission of Texas (Commission) and Phonoscope Enterprises Group, LLC's (Phonoscope) (together, Parties) file this Joint Motion to Abate the Filing of the List of Issues and the Docket for 60 days.

I. BACKGROUND

On December 11, 2018, Commission Staff filed a Petition to Revoke Phonoscope's SPCOA No. 60361 for non-use, failure to respond to the Commission, and failure to comply with Commission reporting requirements. On January 28, 2019, Phonoscope filed a request for a hearing. On August 16, 2019, the Commission issued an Order of Referral to SOAH. The Order of Referral directed Parties to file a list of issues to be addressed in the docket by August 23, 2019.

II. REQUEST

During the weeks preceding the Commission's Order of Referral, Commission Staff and Phonoscope had discussions regarding the Petition to Revoke Phonoscope's SPCOA. Commission Staff and Phonoscope agreed that they may be able to narrow the scope of a hearing, eliminate the need for a hearing, or settle the case.

To continue these negotiations, Commission Staff and Phonoscope request relief from submitting a list of issues and a general abatement of the case for 60 days. At the end of 60 days, Commission Staff and Phonoscope will file a status report.




