The Staff of the Public Utility Commission of Texas and Phonoscope Enterprises Group, LLC ("Phonoscope") file this status report and response to SOAH Order No. 2.


Order No. 2, issued on October 4, 2019, requires parties to file a status report and make a recommendation for further processing of this matter on or before December 2, 2019. This filing is timely made.

On November 22, Phonoscope informed Commission Staff that it had completed its compliance corrections. Therefore, Commission Staff no longer seeks to pursue revocation of Phonoscope's Service Provider Certificate of Authority. Staff will file a withdrawal of the petition.
