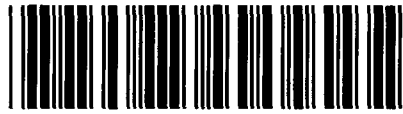

Staff of the Public Utility Commission of Texas (Commission Staff) files this Notice of Withdrawal and Request to Close Docket and would show in support as follows:


On December 11, 2018, Commission Staff filed a Petition to Revoke Phonoscope Enterprises Group, LLC's (Phonoscope) Service Provider Certificate of Operating Authority (SPCOA) under PURA §§ 54.008 and 54.105 and 16 TAC § 26.111.

In accordance with 16 TAC § 22.181(g)(1), Commission Staff withdraws its application without prejudice to refiling. Commission Staff further requests that this docket be closed. Phonoscope has corrected the compliance issues that led to Staff's filing of the Petition to Revoke. Given these corrections, Staff believes that revocation of Phonoscope's SPCOA does not serve the public interest. If in the future, Commission Staff finds it necessary to seek revocation of Phonoscope's SPCOA, administrative penalties, or both, Commission Staff will request that a new docket be opened.
