COMMISSION STAFF'S MOTION TO MODIFY ORDER NO. 2

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Motion to Modify Order No. 2, and would show the following:

I. Background

On December 14, 2018, Order No. 1 in Docket 48975 was issued and directed Commission Staff to file a recommendation regarding the administrative completeness of Punkadilly, LTD's (Punkadilly) request to amend Aqua Texas, Inc's (Aqua) Certificate of Convenience and Necessity in Denton County by Expedited Release on or before December 19, 2018. On January 4, 2019, Order No. 2 was issued finding the petition administratively complete and establishing a procedural schedule. However, the procedural schedule approved in Order No. 2 contains an error relating to filing deadlines for the parties, requiring a response from Punkadilly before Aqua is given an opportunity to respond to the application. Consequently, Staff recommends the Supplemental Procedural Schedule provided below:

Deadline for Aqua Texas and intervenors to file a response to the administratively complete petition	January 22, 2019
Deadline for Commission Staff's recommendation on final disposition	January 24, 2019
Deadline for Punkadilly to file a reply to Aqua's response and Commission Staff's recommendation on final disposition	January 30, 2019
60 day administrative approval	March 5, 2019

II. Conclusion

Staff respectfully requests Order No. 2 be modified as described above.


