This filing serves as official written notice under Public Utility Regulatory Act ("PURA") § 56.032(c) and 16 Texas Administrative Code ("TAC") § 26.407(d) that *Cameron Telephone Company, LLC* elects to have its Texas Universal Service Fund ("TUSF") support paid in fixed monthly amounts to be determined and adjusted pursuant to the mechanism set forth therein.

I hereby certify that *Cameron Telephone Company, LLC* is not an electing company under PURA, Chapter 58 or 59, and is a Small Provider as set forth in PURA § 56.032(a)(2) and Small ILEC as defined in 16 TAC § 26.407(b)(1).

As of the date of this written notice, *Cameron Telephone Company, LLC* receives Small and Rural Incumbent Local Exchange Universal Service Plan support in the annual amount of \$531,192. Monthly support until adjusted under the mechanism set forth 16 TAC § 26.407 will be in the amount of \$44,266.

In accordance with 16 TAC § 26.407(e)(1), *Cameron Telephone Company, LLC*'s first annual SB 586 report will be filed within two months of the filing date of this written notice. Thereafter, its annual SB 586 reports will be filed by September 15 of the following year. These reports will be filed in accordance with requirements or within any such project as set up for these reports.
