CITY OF MCKINNEY'S MOTION TO INTERVENE

The City of McKinney ("McKinney" or "City") hereby files its Motion to Intervene and in support thereof shows as follows:

1. The Cities of Garland, Mesquite, Plano and Richardson ("Petitioners") filed a petition appealing the wholesale water rates imposed by the North Texas Municipal Water District ("NTMWD") pursuant to a contract. The Petitioners allege that the rates adversely affect the public interest.
2. The City of McKinney is one of several municipalities, that include the Petitioners, that has entered into a contract with the NTMWD for wholesale water.¹
3. The Commission's decision in this matter may affect the rates that the City of McKinney as well as its residents pay for water service. Therefore, pursuant to 16 Tex. Admin. Code § 22.103, the City of McKinney has standing to intervene in this proceeding since it has a justiciable interest which may be adversely affected by the outcome of this proceeding.


