**RAYBURN'S NOTICE OF
ERCOT 4CP DATA FOR TRANSFER LOAD**

On March 13, 2019, the Public Utility Commission of Texas (Commission) issued a Final Order in Docket No. 48400, *Joint Application of Rayburn Country Electric Cooperative, Inc. and Lone Star Transmission LLC to Transfer Load to ERCOT, For Sale of Transmission Facilities, and Transfer of Certificate Rights in Henderson and Van Zandt Counties* (Order). The Order authorized Rayburn Country Electric Cooperative, Inc. (Rayburn) to integrate certain load and associated facilities into the Electric Reliability Council of Texas (ERCOT) system according to the terms of the Order. Ordering Paragraph No. 17 requires Rayburn to calculate and file in Project No. 49051 the 4CP data for the transfer load for the calendar year before Rayburn's expected integration date as soon as the data is available.¹ Accordingly, the table below reflects the ERCOT 4CP data for the load that is to be transferred into the ERCOT system on the integration date.

On October 21, 2019, ERCOT provided to Rayburn the final 4CP peak periods, which Rayburn used to calculate the 4CP information for the transfer load. The transfer load is that of Rayburn's member cooperative, Trinity Valley Electric Cooperative (TVEC). The load is currently located in the Southwest Power Pool and will be transferred into TVEC's current TDSP area in ERCOT. In accordance with Finding of Fact No. 85 in the Order, Rayburn submitted this information to ERCOT on October 22, 2019. Rayburn will also file this information in the docket that will be opened to set the 2020 wholesale transmission service charges for ERCOT.
