

**JOINT NOTICE THAT  
RAYBURN INTEGRATION WILL BECOME OPERATIONAL**

As required by Ordering Paragraph No. 14 in the Final Order of the Public Utility Commission of Texas (Commission) in Docket No. 48400 (the Final Order),<sup>1</sup> Rayburn Country Electric Cooperative, Inc. (Rayburn), Oncor Electric Delivery Company LLC (Oncor), and Electric Reliability Council of Texas, Inc. (ERCOT), jointly file this notice that the integration of certain Rayburn load and associated facilities into the ERCOT System is anticipated to become operational beginning at **10:00 am, January 6, 2020**. The integration of Rayburn's load is planned to occur in three phases, with the first concluding on January 6, 2020, and the second concluding on January 7, 2020. Each of the first two phases will establish a radial connection from Rayburn's load to the ERCOT system. The third phase, which will fully network Rayburn's load into the ERCOT system as contemplated in Docket No. 48400, is estimated to conclude on January 21, 2020. The parties will notify the Commission if there are any changes to these operation dates.
