COMES NOW, Respondents Saddlebrook Community and Sun Communities, Inc. ("Sun"), and file this Joint Status Report, as required by Order No. 4.

**I.**

On April 11, 2019, Complainant Deborah Lowe filed a letter stating that she is willing to dismiss her complaint if Sun provided her with notice that Sun will not seek to collect the \$23.91 due to Sun because of an underpayment.
