
2. The amount of customer deposits and the balance of an account in which customer deposits are held (SUBST. R. 25.107 (f)(2)(B)).



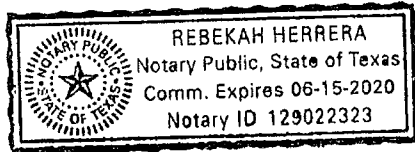


