

COMES NOW, Laguna Madre Water District ("**LMWD**"), and pursuant to the Order of Referral issued by the Public Utility Commission of Texas, offers the following list of issues to be included in the Commission's preliminary order, to be addressed in this docket:

1. Determining whether LMWD's raw water rate is reasonable.
2. Determining whether LMWD's raw water rate is based upon the August 2018 Water and Wastewater Rate Study and Financial Report from the Willidan Group.
3. Determining whether the independent Water and Wastewater Rate Study and Financial Report sets forth a reasonable raw water rate, by recommending a raw water rate of \$1.04 per 1,000 gallons.


