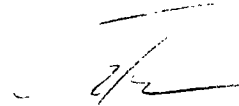

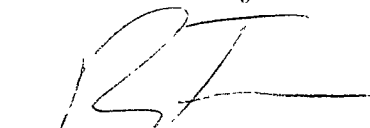

DEFINITIONS
