

**DEFINITIONS**

- A. "COA," "AW" or "you" refers to the City of Austin d/b/a Austin Water and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

The percentages in Microsoft Excel row 463 do not match the proportion of total O&M costs assigned to each function shown in Microsoft Excel row 462. Did Austin Water mean for the allocation proportions in row 463 to match the total O&M costs shown in row 462? If yes, will Austin Water file a correction to this allocation factor, which is used to allocate non-rate revenue line items?
