ORDER REQUESTING LIST OF ISSUES

The City of Austin (Austin Water) filed an application under Texas Water Code (TWC) § 13.044(b) and in compliance with the Commission's order on rehearing in Docket No. 42857¹ for authority to change its water and wastewater rates.

The Commission will issue in this docket a preliminary order that will contain a list of the issues to be addressed in this docket, and any necessary statement of Commission policy, precedent, or position on any threshold legal or policy issues relevant to this proceeding. To assist the Commission in drafting that order, Austin Water must, and the Commission Staff and any other interested party may, file in this docket a list of issues to be addressed in the docket by May 17, 2019. This pleading may also identify any issues that should not be addressed in the docket, and identify any threshold legal and policy issues that should be briefed for purposes of a preliminary order. Specific explanations should support any issues not to be addressed or threshold issues identified in the pleading. Parties must not file responses to any pleading submitted in response to this Order, unless specifically requested.

The Commission's preliminary order will provide a list of issues and areas that must be addressed in this proceeding as required by Texas Government Code § 2003.049(e) and any necessary statement of Commission policy, precedent, or position on threshold issues, or combination thereof, relevant to this proceeding as required by Texas Government Code § 2001.058(c). After receipt and review of the list of issues filed in this docket, the Commission will consider and adopt a preliminary order.
