NORTH AUSTIN MUNICIPAL UTILITY DISTRICT NO. 1, NORTHTOWN MUNICIPAL UTILITY DISTRICT, TRAVIS COUNTY WATER CONTROL & IMPROVEMENT DISTRICT NO. 10, AND WELLS BRANCH MUNICIPAL UTILITY <u>DISTRICTS' MOTION TO INTERVENE</u>

TO THE HONORABLE COMMISSIONERS:

COME NOW, North Austin Municipal Utility District No. 1, Northtown Municipal Utility District, Travis County Water Control & Improvement District No. 10, and Wells Branch Municipal Utility District (collectively the "Districts") and file this Motion to Intervene ("Motion") in this docket for the Application filed by the City of Austin ("City" or "AWU") requesting authority to change the water and wastewater rates of the Districts. In support of their Motion, the Districts will respectfully show the following:

I. INTRODUCTION AND BACKGROUND

1. On April 12, 2013, the Districts originally appealed the wholesale rates that the City charged them. That appeal proceeded under Section 13.044 of the Texas Water Code.

- 2. On January 14, 2016, the Public Utility Commission of Texas ("Commission") issued an Order on Rehearing in Docket No. 42857 ("Final Order") in which the Commission ordered AWU to not increase water or wastewater rates for the Districts without prior Commission approval.²
- 3. As part of that Final Order, the Commission found the following cost categories inappropriate for inclusion in the reasonable and necessary costs for provided water and wastewater service to the Districts:
 - a. General fund transfer;
 - b. Rate case expenses;
 - c. Reclaimed water system (capital and O&M costs);
 - d. City's reclassification of SWAP and commercial paper administration costs from capital to expense;
 - e. Drainage fees;
 - f. Allocation of O&M expenses for reclaimed water utility;
 - g. Depreciation;
 - h. Green Water Treatment Plant capital costs;
 - Revenue Stability Reserve Fund;
 - j. Barton Springs Edwards Aquifer Conservation District;
 - k. Govalle Wastewater Treatment Plant (capital and O&M costs);
 - 1. Utility-Wide contingency costs;
 - m. Water Treatment Plant No. 4; and
 - n. Green Choice electricity.³

- 4. On March 29, 2016, the City filed its Original Petition for Judicial Review with the District Court in Travis County, Texas.⁴
- 5. On May 25, 2017, Judge Livingston of the 53rd Judicial Court of Travis County, Texas issued a Final Judgment denying the City's appeal and affirming the Commission's Order on Rehearing.⁵
- 6. As required by §13.044(b) of the Texas Water Code, on April 15, 2019, the City filed an Application for Authority to Change Water and Wastewater Rates in this docket (the "Application").
- 7. The Application seeks to change the water and wastewater rates that the City may charge the Districts. The proposed change to these rates would directly and uniquely impact the Districts.

II. MOTION TO INTERVENE

8. Because the outcome of this proceeding may adversely affect a justiciable interest of the Districts, the Districts hereby move to intervene in this docket and request party status as Intervenors.
