**I.**


On June 26, 2020, the Petitioners and the City of Celine filed a Joint Motion to Abate the hearing, as the parties had tentatively settled the rate dispute. The honorable Administrative Law Judges issued their Order No. 7 abating the matter and requiring the filing of a status report.


