COMMISSION STAFF'S REVISED PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Revised Proposed Procedural Schedule in Response to Order No 7. In support thereof, Staff shows the following:

I. BACKGROUND

On February 15, 2019, Simply Aquatics, Inc. and the Timberlane Water System, Inc. (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Sabine County, Texas. Specifically, the Applicants seek to transfer Timberlane's facilities and service area under water Certificate of Convenience and Necessity (CCN) Number 12336 to Simply Aquatics. The requested transfer includes approximately 13 acres and 47 current customers.

On January 3, 2020, Order No. 7 was issued, establishing a deadline of January 14, 2020, for Staff to file a revised proposed procedural schedule for further processing of the application. Therefore, this pleading is timely filed.

II. REVISED PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following schedule:

Deadline for parties to file a response to Staff's recommendation	February 19, 2020




