



APPLICATION OF TIMBERLANE WATER SYSTEM, INC. AND SIMPLY AQUATICS, INC. FOR SALE, TRANSFER, OR MERGER OF FACILITIES AND CERTIFICATE RIGHTS IN SABINE COUNTY

## COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF CLOSING DOCUMENTS

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Recommendation on Sufficiency of Closing Documents. In support thereof, Staff shows the following:

#### I. BACKGROUND

On February 15, 2019, Simply Aquatics, Inc. and the Timberlane Water System, Inc. (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Sabine County, Texas. Specifically, the Applicants seek to transfer Timberlane's facilities and service area under water Certificate of Convenience and Necessity (CCN) Number 12336 to Simply Aquatics.

On September 1, 2020, the Administrative Law Judge issued Order No. 17, requiring the Applicants to file supplemental documentation addressing the deficiencies identified in Order No. 16 by September 14, 2020. The Applicants filed supplemental closing documents on September 10, 2020. Order No. 17 also required Staff to file a supplemental recommendation on the closing documents by September 28, 2020. Therefore, this pleading is timely filed.

### II. SUPPLEMENTAL SUFFICIENCY OF CLOSING DOCUMENTS

Staff reviewed the Applicants' closing documents filed on September 10, 2020, along with the customer deposit records filed on July 13, 2020. The supplemental documentation meets the requirements of 16 Texas Administrative Code §§ 24.239(k)-(n). Therefore, Staff recommends that the Applicants' closing documents be found sufficient, because the Applicants have cured the deficiencies identified in Order No. 16 and customer deposits have been appropriately addressed.

Deadline for parties to file a proposed Notice of Approval, including proposed findings of fact, conclusions of law, and ordering paragraphs

Staff respectfully requests the issuance of an order finding the closing documents sufficient and adopting the proposed procedural schedule.
