



COMES NOW, Ponder Enterprises, Inc. dba Longhorn Company ("Ponder"), by and through its undersigned attorneys of record, and files this Notice of Consent, and, in support thereof, would respectfully show as follows:

I. BACKGROUND

On February 15, 2019, Lone Star Water Company ("Lone Star") and Ponder (collectively the "Applicants") filed an application for sale, transfer, or merger of facilities and certificate rights in Denton County, Texas at the Public Utility Commission ("Commission"). The Commission has previously authorized the Applicants to close on the transfer of the systems, and the Applicants have closed on such transaction. On December 2, 2019, by correspondence attached hereto as Exhibit A, Commission Staff provided final maps for the Applicants' respective review and approval. This correspondence directed the Applicants to review the maps and submit executed consent forms to the Commission on or before December 13, 2019. This pleading is therefore timely filed.

II. CONSENT

Ponder hereby submits its executed consent form attached hereto as Exhibit B, which evidences Ponder's concurrence with the maps and certificates transmitted to it by email on




