

does not currently conduct business under an assumed name.



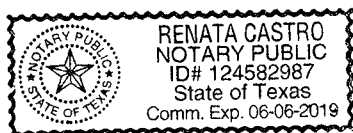

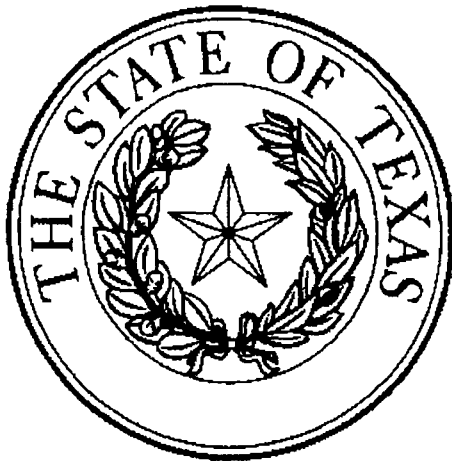
